Experience with and Interest with the Algoma NP Led Clinic

I have no experience with the clinic but am well aware of its existence. I have worked with Nurse Practioners in my previous role and feel their contribution to healthcare is invaluable. Breaking Away is a not for profit organization founded 11 years ago by a group of parents whose physically and mentally challenged children had nowhere to go after their high school program. The basis of the program is to teach life skills and to further develop socialization skills.
