2.0 | Presentation and Discussion

2.1 | Project Review: Key Themes and Opportunities

AOHT Chair (Dr. David Fera) welcomed Ila Watson to provide an overview of the Project Status Report Summary provided in the meeting package. Ila overviews three key themes identified as a result of Project Check-In meetings; Engagement and Support across AOHT Partner Organizations, Building Capacity for Collaboration, and Proactively assigns roles and accountability.

The need for a "Lead Agency" on each AOHT project was amplified through discussion.

2.2 De-brief Meeting with Northern OHTs

AOHT Chair invited Stephanie Parniak and Jennifer Osesky to provide an overview of a meeting called by the Ministry of Health with the Northern OHTs held on June 14th, 2021. Stephanie Parniak provided an update on how Patient and Family Advisory Councils can play a role in the AOHT and Jennifer Osesky announced that the Ministry is working closely with Ontario Health to establish a model that would work across the north to provide full coverage across the northeast by the end of the fiscal. Ontario Health North is partners with the Ministry in OHT development. A shared-decision making, co-design approach to establishing what an OHT model could look like in the north was presented at the meeting as additional challenges have been identified in this region.

2.3 Indigenous Health, Equity and Partnerships

AOHT Chair invited Michelle Brisbois to lead a brief discussion on Indigenous health and equity. It was identified that the AOHT needs to look at the seven healthcare specific actions presented in the Truth and Reconciliation: Call to Action document. It was identified that it is our responsibility to be leaders in making active changes in equitable healthcare in the north. Shauna gave an overview on the partnership and relationship building work with our Indigenous partners that is being done at Sault Area Hospital.

3.0 Consent: Collaborative OHT Leadership (Governance)

3.1 | Funding Proposal: Remote Care Monitoring for Mental Health and Addictions

AOHT Chair invited Erik Landriault to give an overview of the funding proposal provided in the meeting package. The importance of mental health and addictions was recognized. The funding proposal was submitted on June 11, 2021, prior to being presented as a consent and information item in the Leadership Council meeting.

While recognizing the short turnaround deadlines for funding applications, all efforts should still be
made to ensure the Leadership Council sees all applications for funding prior to submission. Dr. Jodie
Stewart requested the implementation of a mechanism for the Leadership Council to approve funding
applications. This is to reduce silos and increase input into the applications.

3.2 | Home and Community Care Consultation



AOHT invited Erik Landriault to give an overview of the Home and Community Care consultation. An invitation to meet on this work is going out to Leadership Council members. The AOHT was recommended to share that we want to embed care coordination in primary care.

3.3 | AOHT Audit Report

Erik announced that there were no issues with the Audit Report presented in the meeting package and that it will be approved and signed by the Sault Area Hospital (Fund Holder) Board at the Annual General Meeting at 4:00 pm on June 21, 2021.

4.0 | Committee Updates

4.1 | Action Team Updates:

COVID-19: Status and Transition:

Dr. Jodie Stewart gave an update on vaccine distribution and administration in Algoma.

- We are starting to get large volumes of vaccines and clinics are starting to develop across the region.
- We will be working on a ramp-down plan toward the end of summer and begin to move away from an MIC model.

Quality Improvement Committee:

Erik Landriault gave an update on behalf of Dominic Noel and the committee.

• The team is putting together a Performance Dashboard that the committee will review in September.

Community Wellness Bus:

Erik Landriault provided an update on behalf of Annette Katajamaki.

- The team has drafted a Partnership Agreement.
- Team is looking on how to sustain and resource the development of new programs and initiatives (i.e. Hub manager).

Citizen Reference Panel Design Team:

Shauna Hynna provided an update on the Citizen Reference Panel.

- The report will be complete in approximately two weeks.
- Prioritizing the recommendations in the report will be of importance moving forward.
