### FEDS: Looming election on the horizon

- If an election were held today, the Conservatives lead by nearly 20 points over the Liberals and would win a massive majority government.
- The end of the Liberal-NDP deal returns Canadians to traditional minority Parliament politics.
- The Liberals only need to secure the support of the Bloc or the NDP to win confidence votes and avoid early elections.
- A Federal Election could be called anytime between now and October 2025.

### **Evidence of Electioneering**

- Ford's Progressive Conservatives are in electioneering mode
- Looking for wins, quick wins and announcements in Progressive Conservative strongholds
- Government less likely to do announcements or investments in Liberal or NDP strongholds, unless it's a swing riding.
- Examples include announcements at member centres.

Deputy Minister and Minister of Health
Jones and other MPPs announced an
investment of over \$14 million to
connect up to 49,000 people to primary
care teams in Toronto. The
Announcement was made at TAIBU CHC
and was part of the \$110M previously
announced





## Ontario Protecting Communities and Supporting Addiction Recovery with New Treatment Hubs

- On August 20<sup>th</sup>, The Ontario government announced that it is protecting the safety of children and communities by banning supervised drug consumption sites within 200 metres of schools and childcare centres.
- In order to restrict access to dangerous and illegal drugs moving forward, the government will also introduce legislation this fall that would, if passed, prohibit municipalities or any organization from standing up new consumption sites or participating in federal so-called "safer" supply initiatives.
- If passed, the legislation will also prohibit municipalities from requesting the decriminalization of illegal drugs from the federal government.
- As part of a comprehensive system of care that prioritizes community safety and focuses on giving people their lives back through treatment and recovery, as well as upstream investments in prevention, the province is investing \$378 million in 19 new Homelessness and Addiction Recovery Treatment (HART) Hubs.



### Ontario's Fall Economic Statement (FES)

- On October 30, the provincial government released the <u>2024 Ontario</u> <u>Economic Outlook and Fiscal Review</u> (English) or <u>Perspectives</u> <u>économiques et revue financière de l'Ontario 2024</u> (Français).
- Ontario Finance Minister Bethenfalvy's <u>statement</u> focused on Ontario's improving fiscal position and provincial credit rating, building highways and transit, reducing gridlock, and improving affordability issues impacting individuals and families.

### Ontario's Fall Economic Statement: Summary

#### **Health Care Investments Announced in 2024 FES**

- The government announced plans to:
  - Invest an estimated \$88 million over three years to expand Learn and Stay grants for 1,360 eligible undergraduate students who commit to practicing family medicine with a full roster of patients once they graduate (beginning in 2026). It is estimated the total investment will enable the connection of an additional 1.36 million people to primary care based on average attachment rates for family doctors.
  - Expand access for families who are seeking fertility treatment. Beginning in 2025–26, the government will invest an additional \$150 million over two years to expand the Ontario Fertility Program (OFP).

# Ontario's Fall Economic Statement: Summary Cont'd

- Prioritizing access for Ontario residents for medical school seats and expanding medical school education to enhance health care capacity and access to primary care services.
- The government is investing more than \$13 million over three years, starting in 2024–25, to establish an Amyotrophic Lateral Sclerosis
   (ALS) provincial program and expand regional services into Northern Ontario.
- The government is investing close to an additional \$17 million over the next three years to expand access to services and activities for seniors through 100 new Seniors Active Living Centres (SALC) programs across the province.

### Ontario's Fall Economic Statement: Analysis

#### What is Missing from the 2024 FES

- Urgency around addressing the primary sector investment crises or a plan on how the Ontario Government will address the pressures workers face related to the cost-of-living crisis.
- Explicit investments to address the cost-of-living crisis facing health care workers demonstrates the need for urgent action.
- Details on the scope of Dr. Jane Philpott's Primary Care Action team mandate, and how the government plans to commit to fund its stated goal of "100% attachment rates to primary care" for everyone in Ontario.

### **Ontario's Fall Economic Statement: Next Steps**

- The Fall Economic Statement includes a commitment to better services for Ontarians while addressing the costs of living, but nothing is being done about the compensation crisis facing health care workers and the organizations they work for.
- The Alliance has shared a plan on how we will advocate over the next 45 days for immediate funding in Budget 2025 for our members to support operational, human resource and capital pressures through ongoing advocacy asks, across all MPP ridings where Alliance member organizations serve people in Ontario.

## Ontario Medical Association (OMA) Arbitration Award for Year 1 of Deal with Doctors Announced

- On **September 12<sup>th</sup>, 2024**, the **OMA** announced that a Board of Arbitration, chaired by Mr. William Kaplan, released a decision awarding a **9.95 percent increase** for the **first year of a four-year agreement** between the **Ontario government and Ontario's doctors**.
- The award is **retroactive** to **April 1, 2024**.
- The next three years of the Physician Services Agreement will continue to be negotiated between the province and the OMA.

# Dr. Jane Philpott to Chair Primary Care Action Team

- Dr. Jane Philpott will serve as chair and lead a new primary care action team with a mandate to connect every person in Ontario to primary health care within the next five years.
- Starting December 1, 2024, in her new role, Dr. Philpott will oversee this action-oriented group supported by the Ministry of Health.
- Plan will ensure Minister of Health can further expand team-based primary health care across the province. Plan to include:
  - More convenient access to existing teams
  - Better service on weekends and after-hours
  - Reducing the significant administrative burden on family doctors & Primary Care Providers
  - Improving connections to specialists and digital tools.

# Ontario Health's 2024/2025 Annual Business Plan (ABP)

- Ontario Health (OH) has released its <u>Annual</u> <u>Business Plan (ABP) for the 2024-2025 fiscal</u> <u>year.</u>
- OH's ABP is a "critical planning document that sets out how [OH] will deliver on the government's overarching goals and priorities over the next three years, with a focus on fiscal year 2024/25. The work presented in the 2024/25 ABP is guided by the priorities outlined in the Ministry of Health's (MOH's) Your Health Plan and Letter of Direction to Ontario Health and the strategic priorities letter from the Ministry of Long-Term Care (MLTC)" (p. 4).



# Ontario Health's 2024/2025 Annual Business Plan(ABP): Delivery Priorities

Ontario Health's 2024/2025 ABP is centred around 6 Delivery Priorities:

- Reduce health inequities: This ABP outlines OH's focus areas for reducing health inequities (OH stresses that it applies this lens throughout the plan).
- Advance the Your Health focus on the right care in the right place through transforming care with the person at the centre: This ABP outlines OH's areas of focus to advance health system integration and care for patients and care partners through a person-centred approach.
- Advance the Your Health focus on faster access to care and supporting health care
  workers through health system operational management, coordination,
  performance measurement and management, and integration: This ABP outlines
  OH's areas of focus aiming to improve the experience of Ontarians in accessing time
  sensitive-care and support front-line staff.



# Ontario Health's 2024/2025 ABP: Delivery Priorities Con't

#### Ontario Health's 2024/2025 ABP is centred around 6 Delivery Priorities:

- Enhance clinical care and service excellence: This ABP outlines OH's planned activities and deliverables to enhance its provincial clinical programs and services.
- Maximize system value by applying evidence: This ABP outlines OH's steps towards strengthening its capacity to collect, share, integrate, analyze and react to data and evidence. OH also details its commitment and work towards establishing itself as a core provincial data utility for the province and collaborating with the MOH to establish new data authorities that enable the agency's ability to drive the government's improvement agendas.
- Strengthen Ontario Health's ability to lead: This ABP highlights OH's planned activities and deliverables to enhance OH's organizational effectiveness through a strong, engaged, connected, diverse, and accountable workforce, and how it will support the government's plans for supply chain centralization.

# Ontario Health Mental Health and Addictions Centre of Excellence (MHA CoE)

#### Responsible for:

- The MHA CoE supports Ontario in building a comprehensive and connected mental health and addictions system.
- It plays a critical role in **overseeing the delivery and quality** of mental health and addictions services and supports, including system management, supporting quality improvement, disseminating evidence, and setting service expectations.
- The MHA CoE will also help implement **key priorities within the Roadmap to Wellness**, the province's plan to build a comprehensive and connected mental health and addictions system.
- The MHA CoE will apply a **system improvement approach** like that of Cancer Care Ontario (now Ontario Health), and other successful provincial agencies.

# Mental Health and Addictions Centre of Excellence (MHA CoE) Clinical Priorities Areas of Focus

#### Depression & Anxiety-related Disorders Clinical Program

- Enhance and integrate services across the depression & anxiety-related disorders continuum of care to ensure an accessible, standardized, evidence-based and high-quality system.
- Multiple areas of focus for this work to ensure a coordinated and connected stepped-care model.
- Ontario Structured Psychotherapy Program.

#### Substance Use Disorders Clinical Program

- Improve the health and well-being for and with people who use substances through increased access to and delivery of high-quality, evidence-informed care that is respectful, trauma-informed, and compassionate.
- Enhance primary and community care services, and integrate mental health, addictions, and medical care to improve client and system outcomes.



# Mental Health and Addictions Centre of Excellence (MHA CoE) Clinical Priorities Areas of Focus Cont'd

#### Schizophrenia & Psychosis Clinical Program

- To ensure standardized, high-quality services for schizophrenia and psychosis are available across the lifespan to address the needs of Ontarians.
- The first area of focus for this work is early psychosis intervention.

#### Eating Disorders Clinical Program

- To ensure an accessible, standardized, evidence-based, and high-quality provincial eating disorders system in Ontario.
- The first area of focus for this work is outpatient care.



# Multi-Sector Service Accountability Agreement (MSAA) modernization

- Service Accountability Agreements (SAA) advisory committee has been put on hold
- Each association is having 1:1 consultations with SAA lead at Ontario Health
  - Opportunity for OH to reflect on what they heard through the SAA advisory process
  - Reflected that a lot has evolved in the system since starting the SAA refresh process
  - Considering the planning processes (CAPS (Community Accountability Planning Submission), HAPS (Hospital Annual Planning Submission), LAPS (Long-Term Care Annual Planning Submission) and how to better align these tools and considering options given the April 1<sup>st</sup> fiscal year and misalignment with funding confirmations in the fall.
  - Meetings held in July no updates since that time

- The RRN Symposium brought together a diverse group of executive leaders, front-line staff, and board members from various regions of Rural Ontario to explore and generate strategic discussions on how to actualize initial steps toward improving and increasing equitable access to community-based, integrated, and interprofessional primary health care for Ontarians living in the province's RRN communities.



#### Goals



**Increase awareness** of the health human resource crisis in the community health sector and the impact it has on patient care and broader health care system.



Establish a **unified voice** for the community health sector to advocate for solutions to the health human resource crisis and wage gap (while respecting the need for individual advocacy on key sector issues).



Equip members (you!) to engage in grassroots advocacy locally.



Mobilize the Government of Ontario to comprehensively address urgent health human resource challenges in the community health sector in **Budget 2025**.



### Ask to government



Commit to investing over \$500 million annually over the next five years in Budget 2025 to close the wage gap between community health and other sectors, align the community health sector's compensation rates with industry standards, and provide sustainable and ongoing annual increases to community health workers in line with projected inflation.



Address Bill 124 shortfalls immediately, as has been addressed in other sectors.



**Establish a community health human resources working group with key government stakeholders across relevant ministries** to identify sustainable approaches and initiatives to build a workforce that can deliver timely, accessible, and high-quality community health services to Ontarians.




